1. EXECUTIVE SUMMARY

1.1 INTRODUCTION

Hitkarini Sabha, established in 1868 is a non-profit, philanthropic organization extending literary and technical knowledge in the mahakoshal region i.e. eastern Madhya Pradesh and promoting moral, social and intellectual interest and well being of the people. The Sabha is managing 8 colleges, 18 schools and one Computer Center enrolling more than 13,000 students and employing around 1000 teachers and staff. It is imparting value-based education in the field of law, humanities, education science, computer, nursing, engineering, architecture and dentistry. Hitkarini Dental College & Hospital is the 8th college established by Hitkarini Sabha, which is one of the oldest educational institutions in the region. Hitkarini Sabha was established in 1868, 150 years ago. Since then it has grown from providing elementary school education to professional and technical education through quality institutes in the field of arts, science, commerce, education, law, nursing, engineering, architecture and dentistry. Hitkarini Dental College & Hospital is the first college of dentistry in eastern Madhya Pradesh. The college is situated in a picturesque location on the airport road in Jabalpur. There is a regular flow of 100 to 150 patients per day for treatment and the number is increasing. This helps in the ensuring that the students will be exposed to good practical knowledge and clinical material as well.

Curricular Aspects

The institution ensures the effective delivery of its curriculum through meticulous planning and execution. The curriculum is designed in alignment with the guidelines provided by Madhya Pradesh Medical Science University, Jabalpur, and the Dental Council of India. Infrastructure and Learning Resources

The College provides a state of the art infrastructure that caters to the needs of students, faculty and patients to

offer the finest patient care and technological resources. Special care is taken to maintain cleanliness and hygiene at all places. A fully air conditioned college conference room is available with updated audiovisual aids with internet connectivity to organize several programs like clinical skill development programs, committee meetings, core group meeting with management, brain-storming sessions along with the group discussions. An 200 seated auditorium provisdes a common platform for all intellectual and cultural activities for the students and faculties along with the reputed guest speakers from various fields through CDE programs, Workshops, Interdepartmental activities, and Conferences etc. The excellent facilities of audiovisual aids along with comfortable seating arrangement are the special feature of the auditorium. It is air-condition theater with step wise placement of chairs for better visibility. Collar mike and Cordless mike are available for interaction with audience. The institution is having air-cooled central library with the built-up area of 9922 sq. ft. with 166 seating capacity for students. A separate journal section having international and national specialty driven journals with proper catalogue system are available. Library is equiped with browsing room with 10 to facilitate E-learning. All the departments are having a departmental library with relevant subject textbooks and reference books to enable student and faculty for instant access for reference purposes within department. The institution is having 2 Satellite Centres where students are posted on rotation basis for routine screening and also staff handle the emergency treatment and refer to college hospital for further treatment. Properly designed and equipped Preclinical Labs are available for preclinical teaching and training in various subjects. Digital Dental Radiography with both intraoral and extra oral techniques like IOPA, RVG, OPG and CBCT facilitate student learning. Several sports and cultural facilities are made available to students in form of Gymnasium, Yoga Room, Recreation Room, badminton etc.

Student Support and Progression

Hitkarini Dental College and Hospital provides an ideal environment for the academic and extra-curricular activities of the students. The college conducts several developmental programs to enhance the capabilities of the students. Such developmental programs include: Analytical Skill development, Soft Skill development, Language and Communication Skill development, Yoga, Human value development, Personality and Professional development, Employability development. Apart from that vaccination programs, blood donation camps are also arranged. And most of the programs are arranged by the willingness of the students and their effort as well.

Several lectures are conducted for the students to participate in several competitive examinations. Both inhouse teachers and invited speakers provide lectures to prepare the students for their upcoming competitive examinations.

The college has set up three committees: Internal Complaint Committee, Grievance Redressal Committee and Anti-Ragging Committee. All the three committees are very active and they maintain a transparency for the processing of the committee. Meetings of each committee is held twice or thrice in a year and reports are uploaded to Dental Council of India.

The college keeps a yearly record of the students those who have qualified in state and national level examinations. The college keeps the records of placement /self-employment of the students in their relevant field. The students as per their merit are also provided opportunities to join the college.

The College Students take active part in a variety of literary and cultural activities including extempore speech, poetry, quiz, etc. The College won several prizes in the Hitkarini Sabha Vidya Parishad Competition. The annual cultural function "Envision" is held in every year.

A student council is also there for the activities related to student welfare and student representation in academic and administrative bodies/committees of the institution. Records are kept by the college regarding the average number of sports and cultural activities/competitions organized by the college itself. These cultural and sports activities are organized by the faculties with the help of the students throughout the year.

The Alumni Association is very active in the college. Several books and furniture are donated by the Alumni Association.

Governance, Leadership and Management

The institute has a well-defined vision and mission that also addresses the needs of all its stakeholders. It has got a strong internal organizational structure, and an effective decision making process. Information regarding the institute, faculty and their areas of specialization, days of availability, timings is available on the college website www.hdch.com, which is updated regularly. Steps has been taken by the institute to develops egovernance strategies, ensuring the organization's management system development, implementation and continuous improvement, reinforcing a culture of excellence, identifying organizational needs and striving to fulfil them. Institute also promotes a culture of participative management and also groom leadership at various levels. The institution is always keen in promoting the excellence both in academic as well as in clinical field. It also inculcates sound value system, fostering global competencies, National development etc. among its students. Audits are regularly conducted to monitor and to ensure oral health care quality, patient safety and satisfaction by various institutional committees (Institutional Ethics and Review Board, Institutional Bio-safety and Environmental Committee) and Feedback system, which are regularly reviewed in various meetings. A systematic and robust mechanism is in place to document, compile, analyze and redress the feedback mechanism whilst maintaining the necessary confidentiality.

Significant efforts have been made by the institute to enhance the professional development of teaching and non-teaching staff. Faculty members are motivated and are given various incentives to attend hands on courses, workshops, Continuing Professional Development Programs. Annual Report from each department is compiled to form Institutional Annual Report. Based on Performance linked Incentive System (PLIS), increments or academic promotions are given. Various welfare schemes are made available for teaching and non-teaching staff i.e. in Campus accommodation, 24x7 free power supply, medical/dental facility & drugs at highly subsidized rate, Provident Fund, maternity leave, financial support (reimbursement facility) etc. Most of the treatment provided by the hospital to its stakeholders is at highly subsidized rates. Institute also organizes free Oral Health Camps and Health Mela (educational/treatment) in nearby villages. Regular academic and administrative audits are conducted by the Academic Council to ensure quality assurance. These audits are conducted at departmental as well as institutional level. The institution ensures that grievances/complaints are promptly attended to and resolved effectively for better stakeholder-relationship.

Institutional Values and Best Practices

HDCH follow its Vision and Mission wherein all stakeholders are provided with equity irrespective of gender, class, religious association and ethnic background. The institute is focused to secure equal access to quality education and health, economic resources and participation in academic and cultural life for both genders. There are regular visits made in schools, NGOs and Central Jail, Jabalpur for dental examination and treatment free of cost.

HDCH is the only college in Mahakoushal Region. The students have consistently excelled in academics in both under graduate and post graduate courses in university ranking as university toppers, almost every year.

Dental Part

The institution has adequate infrastructure qualified and experienced staff having skill and dedication to impart proper training to the undergraduate and postgraduate students to develop a potential to treat the patients with efficiency in clinical practices related to dentistry. The institution is fully equipped with equipment's with welldesigned classrooms and laboratories augmented with required furniture and fixtures including availability of Information Communication Technology. Preclinical exercises are conducted as per the guidelines of DCI and University with well-planned time allotment. LRM is also well designed following the guidelines of the DCI/University. The institution follows a strict infection control protocol. Periodic disinfection of high contamination areas is performed regularly by fumigation and antiseptic spraying. Orientation programmes are held every year for newly joined BDS and MDS students for preparing them to the college environment and their academic road ahead. Gender Equity Promotional activities are organized every year. Every year, interactive sessions on women empowerment are also organized. The institution celebrates the annual mega cultural event every year with great zeal and enthusiasm. The Code of Conducts is explained to students which will help in achieving desired behaviour in campus. There are briefing given about the Academic Calendar and academic activities. Orientation Program is organized for fresh interns where the importance of internship related with duties and responsibilities including behaviour is explained by Dean, Director and senior faculties. Interns are posted for Dental Camps in Rural areas/Schools, Jail, Primary Health Centers, Satellite Centers to develop skill to handle community related issues.

INTRODUCTION:

The goal of Hitkarini Dental College & Hospital (HDCH) is to support students' holistic growth. At Hitkarini dental college and hospital, we use a variety of student-centered techniques to enhance the educational process for our students. The facility has simulators that let students practice a certain practical skill in a setting similar to that of a patient in order to promote experiential learning. Student extracurricular activities are a crucial component in enhancing the educational experience.

Multidisciplinary activity conduct is a regular occurrence at Hitkarini. A significant component of the dental curriculum is the inclusion of interdisciplinary courses. Postgraduate students present and debate a single case or reviews related to subjects of interest across departments during interdepartmental debates. In order to promote participatory learning, students are encouraged to openly communicate with the professors throughout theoretical seminars and lab/clinical sessions by posing questions. Students are given questions at the conclusion of each session to make sure they understand the material. Participation in journal clubs, seminars, and small group discussions is also highly encouraged for students.

Students are given clinical case scenarios to analyze and provide their diagnosis and plan of therapy. The regular student assessment includes these problem-based learning activities as a crucial component.

At the start of the actual academic year, students receive copies of the schedule. Additionally, at the conclusion of each lesson, the students discuss the prerequisites for the subsequent one. When compared to traditional classroom instruction, these methods improve student learning by enabling self-directed learning through the use of e-learning platforms and libraries.

During the clinical placements, students get instruction that is entirely focused on the needs of the patient. They work directly under the supervision of faculty members, providing the best oral health care possible to meet the needs of each individual patient.

To help students learn from evidence, the protocols for various patient care procedures are revised on a regular basis in accordance with the most recent research. In order to make knowledgeable decisions when providing oral health care, students are also trained in literature searches and in understanding the findings of randomized controlled trials, systematic reviews, and meta-analyses. The institution gives student lectures as another way to advance human ideals. Throughout their clinical years, students are given project assignments to aid with project-based learning.

Response:

The past several years have seen a significant change in the way education is delivered. The most recent instructional aids are utilized to keep up with advancements and adjust to the ever-changing technological growth. LCD projectors and internet-connected PCs are installed in every lecture gallery. Each department has a dedicated seminar room with an LCD projector and PCs connected to the internet. Every member of the teaching staff is proficient in using these tools. Power Point presentations are frequently, though not always, used by faculty members to facilitate classroom discussions. To help students understand the material being taught, animated movies are also projected as part of this.

EFFECTIVE TEACHING AND LEARNING PROCEDURE: Conservative Dentistry & Endodontics, where microscopes with camera attachments are available enabling the procedures to be visualized on the screens; Oral Medicine and Radiology, to provide the students with the ability of correct radiographic interpretation that aid in arriving at an accurate diagnosis. In order to provide patients with prompt, paperless dental health treatment, the institution switched to an electronic health record system (DIMS patient automation software) in 2019. Every instructor and student has received training on how to use this program.

The institute offers faculty members regular training programs to keep them informed and proficient in using information technology in the classroom.

E-LEARNING: Following the COVID-19 pandemic, the university promptly implemented online platforms such as Google Meet to facilitate theory lessons and clinical discussions. All faculty members have received the necessary training in this regard. Before the start of the new semester, internet platforms were used for undergraduate online classrooms, seminars, and journal clubs for postgraduate students.

LEARNING MANAGEMENT SYSTEM (LMS): Teachers upload all power point presentations, demo videos, and mandatory study materials on the college website and in the LMS for students to access as needed. Teachers and students also have access to a variety of electronic tools. For the benefit of the students, teachers also frequently upload topic-specific multiple-choice questions to the LMS.

2.3.5

The teaching learning process of the institution nurtures creativity, analytical skills and innovation among students

Response:

The teaching and learning process ensures that the students develop analytical skills to apply knowledge in day-to-day practice and to analyse the outcome of treatment through clinical postings. They also learn

to apply principles of ethics to evaluate the scientific literature and information to decide the line of treatment.

Nurturing Creativity & Innovation

The students are involved in short research projects during the course of the study. Skills are developed to coordinate & supervise the activities of allied dental health personnel and to maintain all records. Skills are developed at arriving provisional, differential and final diagnosis for patient care and treatment. The laboratory skills acquired by the students during Crown & Bridge, Aesthetic Dentistry and Oral implantology exercises and studying dental morphology help the students to nurture their creativity. Preclinical work is a part of curriculum and work on phantom heads to simulate the oral structures helps them in nurturing creativity and better understanding of the subject. Practice through simulators such as phantom head, restoration of teeth from carries, carving in wax blocks, plaster model teeth preparation, suture techniques as well as advanced clinical procedures like Implant placement, and aesthetic related surgical procedures nurtures creativity.

Nurturing Analytical Skill

The curriculum ensures that the student gains sufficient knowledge to prescribe investigations and analyse them for treatment planning. They are also taught to integrate multiple disciplines into an individual comprehensive sequenced treatment plan using diagnostic and prognostic information for patient care and treatment planning. During clinical training students gain adequate Hands on[1] experience in extractions and other minor oral surgical procedures, Conservative Dentistry, Endodontics, Crown and Bridge, fabrication of Dentures, Periodontal therapeutic procedures and use of Orthodontic appliances. Familiarity with various radiological techniques, particularly intra-oral methods and proper interpretation of radiographs is an essential part of this component of training and has application in clinical diagnosis, forensic identification and age estimation. Towards the final stage of the clinical training. We inculcate analytical thinking and execution skills to our students through our teaching of diagnostics, prognosis and treatment planning. Our clinical course incorporates analysis of radiographs, tracing of key landmarks in the facial region through cephalometric tracing, evaluation of oral tissues excised for histological analysis and critical thinking through the process of elimination for the formulation of a diagnosis. Prior to performing any clinical procedure, students are required to take a comprehensive case history evaluation of the patients. This enables the process of thinking analytically about the possible differential diagnosis, ordering appropriate investigations for each patient, and arriving at a confirmatory diagnosis. Following these steps, the students are subsequently encouraged to formulate an appropriate treatment plan on their own.

Group Discussion

The students are divided into small groups. Each group is given different cases. The students are instructed to discuss among them and suggest a treatment plan. This improves the analytical skill of the student.

2.5 Evaluation Process and Reforms

2.5.1

The Institution adheres to the academic calendar for the conduct of Continuous Internal Evaluation and ensures that it is robust and transparent

Response:

Introduction:

The annual Academic calendar at our institute is designed by the academic council to define the landmark dates. This enables the faculty and students to work meticulously and helps in maintaining the transparency throughout the continuous internal evaluations. This will be prepared well in advance every year and made available to all the faculty, undergraduate and postgraduate students, by means of internal circulation; displaying it on the web site. The academic calendar comprises the day-to-day teaching and internal assessment schedules.

Internal Assessment:

Academic evaluation is periodic and is by way of the regular slip tests and internal assessment exams. Weekly slip tests are conducted for the postgraduates. Apart from this, the undergraduates will be given a schedule for all the three internal assessment examinations, in an academic year well in advance.

Acdemic Evaluation:

The theory exams will be conducted first, adhering to the dates mentioned in the academic calendar. Theory exams will be followed by practical exams and viva-voce for the undergraduate students. To maintain the transparency in the examinations, three question papers will be submitted in a sealed envelope to the examinations cell, by the concerned HOD, one week prior to the examination date out of which one paper will be randomly selected on the day of the examination.

To avoid bias in evaluations, the answer sheets are coded by the examination cell and the blinded answer scripts are sent to the faculty. After evaluation the examinations cell will decode the answer scripts and will display the marks on the notice boards in the various designated areas. The parents also will receive the marks of their respective ward, through SMS. The answer scripts will be shown to the students and the concerned faculty will discuss the shortcomings and necessary improvements with each student. The students will be counseled regarding their strengths and weaknesses for improving their performance in future.

Theory Exams:

A robust and transparent system is adopted by the MADHYA PRADESH MEDICAL HEALTH

SCIENCE UNIVERSITY for the conduction of internal assessment exams for the Postgraduates. The question paper will be prepared by the university and sent just before the examination, through a password protected email. This ensures strict transparency in conducting such exams. The answer scripts will be sent for evaluation, to the concerned department faculty. The results will be displayed on the respective department notice boards and discussed with the students. The marks will be submitted to the Dean of the institute to be in turn, forwarded to the University.

Mechanism to deal with examination related grievances is transparent, time-bound and efficient

Response:

Introduction:

The institute follows complete transparency in conducting the various examinations. Similarly the grievances are also addressed with an open minded and student centric approach, while strictly adhering to the values of the institute.

Transparent:

All the examinations (Internal assessments/University final exams) conducted in the institute will be strictly following the guidelines of the regulatory bodies like the affiliating University. The syllabus and the time frame for each of the internal assessment examinations will be informed to the students, well in advance. After evaluation of the scripts, in case of any grievances, the undergraduate students can directly approach the concerned faculty / Head of the Department and discuss his/her problem and it will be resolved there to the best possible extent. If it is not resolved at this level, the student can give a written appeal to the Examination Grievances Cell appointed by the institute. Following the receipt of a written grievance, the committee will conduct an enquiry and resolve the issue within 7 days.

Time-Bound:

At the University level, if the student scores less marks than expected, he/she can opt for re-totaling, the notification of which will be announced by the University. This re-totaling option is available only for the undergraduate students. Following this, the student can apply for re-totaling of his/her answer script, after paying the prescribed fee. Then, the University will provide a photocopy of the answer sheets to

Reforms in the process and procedure in the conduct of evaluation/examination; including Continuous Internal Assessment to improve the examination system.

Response:

Introduction:

The institute has a well-established and efficient continuous evaluation system, with different types of assessments spread through the duration of every academic year. The processes related to the conduct of internal examinations and declaration of results are controlled and monitored by the Examinations cell of the Institute.

Undergraduate Level:

Various reforms have been introduced, which would help in a better conduct and evaluation of the internal assessment exams and would help the students to gear up for the future final University examinations and various common entrance tests.

- Introduction of Problem based learning questions is a major step which will enable the students to learn and inculcate the habit of orienting the basic science subjects with the clinical applications and thus, help in their more integrated approach to the treatment modalities.
- The institute has also introduced the end chapter exam in the form of Multiple Choice Questions. This would help the students to get a grip on their approach towards answering such MCQ's in the various Entrance Exams in future.
- A set of three question papers are prepared for each internal examination and the final question paper will be picked randomly at the time of examination. To maintain the transparency in the evaluation of papers and to avoid bias, secret code will be allocated to each paper from the Examinations cell. The faculty will receive jumbled papers, thus, blinding them about the names and the related papers. This will ensure transparency in evaluating the answer scripts.

The University has also introduced various reforms for facilitating the methodical approach in conducting the various examinations.

- The University has introduced an online MPMSU.edu.in/result portal, which facilitates the entry of daily attendance from the college, based on the already submitted academic calendar from the institution.
- It also helps in regular entry of the internal assessment marks / results and thus, maintains the transparency in these aspects.
- The hall tickets for students are also generated through this online portal.
- The password protected question papers are shared with the college through this online portal half an hour prior to commencement of the examination. This requires both the Chief superintendent of the examinations from college and the Observer from the University to login simultaneously, for accessing the question papers.
- The coded and jumbled answer scripts will be evaluated online by two different examiners. The papers with large variation in these two valuations will be subjected to 3rd evaluation also and thus, eliminate any chance for bias.
- The entry of practical/viva marks is also made through the online portal.

Postgraduate Level:

The institute strictly adheres to the revised MDS 2017 regulations of the Dental Council of India. Post graduate education in general does not have formative assessments during the entire course. A unique system of conducting internal assessments periodically for post graduate students has been adopted by our University. The question paper will be prepared by the university and sent just before the examination, through a password protected mail.

- Research activities done by the students at various levels, will increase their reasoning ability and research oriented approach to the various clinical scenarios.
- Special emphasis on weaker section students special emphasis is given to impart the knowledge to the weaker section students.
- The assessment of these learning outcomes is based on the knowledge gained by the student; his/her ability to comprehend the knowledge and the ability of a student to analyze and apply the knowledge gained.
- By the end of the course, the students at our institute will be in a position to apply the concepts

taught in basic sciences to the clinical scenarios and use this scientific foundation for molding themselves into better health care professionals and thus, become an asset to the society.

2.6.3

The teaching learning and assessment processes of the Institution are aligned with the stated learning outcomes.

Response:

HDCH has been offering the 5 year Undergraduate (BDS) and 3 year Postgraduate (MDS) programs in dentistry, for more than 2 decades. Teaching/learning in dentistry, is a process which involves attainment of strong knowledge and understanding, while developing cognitive motor skills and attitudes that help a student apply this understanding to attain high standard of professional ethics in delivering services to the community. The stated learning outcomes, as designed by the DCI, in the Revised BDS Course regulation of 2007, for the undergraduates and in the MDS course regulations of 2017, for the Postgraduates are:

- 1.Knowledge and understanding.
- 2.Skills
- 3. Attitudes like human values, ethical practice and communication abilities

Timely formative and summative evaluations done at the end of each year of the program ensure that such teaching, learning process and the program outcomes of each student are assessed thoroughly.

Formative assessments:

1. For undergraduates:

- Meticulously designed practical record with structured evaluation sheet for each exercise.
- Slip tests are conducted at the end of each chapter and mock practical exams, whenever necessary.
- 3 internal assessment exams are conducted. Average of the marks obtained in these 3 internals is taken as internal assessment marks, which will be added to the summative assessment Theory Internals 10 marks & Practical Internals 10 marks. The Academic council and Examinations cell of SIDS will oversee the curriculum implementation and examinations conducted, respectively, from time to time; scrutinize the outcome analysis and also suggest remedial measures where ever improvement is necessary.
- Such teaching, learning & assessment processes see to it that the undergraduate students are trained to extrapolate their cognitive learning to the psychomotor skills in real time case based scenarios and thus, mould themselves into competent professionals.

2. For postgraduates:

- Attendance percentage (minimum requirement 80%) is calculated.
- Meticulously designed practical record with structured evaluation sheet for each exercise. Regular Seminars, Journal club discussions and Case presentations are conducted. The content, preparation, presentation, and communication skills are assessed using separately designed evaluation sheets.
- Pre-university exams are conducted at the end of each year, by the MPMSU, in their prescribed dates and implemented at the institute.
- The Library dissertation and the Thesis works done by each postgraduate will be monitored and assessed by their respective guides from the department, registered under the MPMSU. Such guides record the progress of their respective postgraduates from time to time.

Such teaching, learning & assessment ensures that at the end of such a program, the postgraduates –

• Achieve higher competence in general and special areas of interest;

Are prepared for a career in teaching, research and specialty practice, while attaining high clinical proficiency in the subject and developing competence in research and its methodologies.

Presence and periodicity of parent-teachers meetings, remedial measures undertaken and outcome analysis

Response:

Introduction:

The parent-teacher meetings are given importance at the institute at various levels. These annual meetings help in effectively conveying the performance levels of their wards with the parents. The parents will be kept abreast with the know-how of the institute and its curriculum.

At the time of admission, the Dean will conduct an inaugural meeting which will include the faculty, students and their parents. In this meeting, the parents and students will be made aware briefly, about the curriculum, the learning outcomes and the methods of implementation. Annual Parent teacher meetings for undergraduate students are conducted as per schedule and the parents are generally informed by SMS. Information regarding their ward's attendance and internal assessment marks is also sent to the parents on a regular basis.

Regular progress, attendance and the academic performance of the students is discussed with their parents. The parents of the underperforming students and of those students with the attendance

percentage less than the stipulated 75% will be asked to meet the concerned department HOD and the incharge faculty and the performance of their individual ward will be discussed. The parents / guardians of the postgraduates, who require special attention, will be advised to interact with the concerned Head of the Department / Dean of the institute. Parent's feedback is collected at the end of the meeting and the same is analyzed.

Remedial Measures Undertaken:

- Based on the parents feedback and students performance actions to be taken are drafted which include strengthening the mentor- mentee system, counseling sessions, remedial classes for slow performers, small group discussions etc. The concerned faculties are also appraised to help the students improve their academic performance.
- Appropriate measures are also taken to improve the hostel facilities, recreation facilities and canteen services based on parent's feedback

Outcome Analysis:

• The outcome analysis is carried out based on their performance in the subsequent periodic / monthly tests; retest and the internal assessment exams / clinical activities. The remedial classes and additional clinical hours have helped the students in finishing their clinical quotas before they appeared for their final examinations. All the above-mentioned practices were positively reflected in the university results and as an outcome most of the students have managed to competently complete their BDS course with confidence. Students with other personal difficulties were able to overcome them and fare well in their examinations.

Each department, however, has its own independent specialised departmental library. The library is a resource for an efficient, serious, and intellectual environment that encourages and facilitates quality improvements in

academic and institutional performance. The library is stocked with a wide variety of textbooks, periodicals, digital databases, theses, and library dissertations. There are several collections of materials to support teaching, learning, and research. It also provides students and faculty with pleasure and healthy recreation by distributing various newspapers and publications. The complete collection is divided into different divisions in the library.

The library has a regular portion that includes text books, reference books, and journal sections (national and international), books volumes and an archive section with antique books. Weekly magazines, literature books and autobiographies are examples of non-teaching books.

The library's books and periodicals are updated annually in accordance with the curriculum and annual budget. The books cover all dental disciplines as well as basic medical sciences in recent editions and newer works.

Undergraduate Section

The undergraduate library has year specific subject books for students such as Basic Science category subjects such as Anatomy, Physiology, Biochemistry, General Medicine, General Surgery, General Pathology, and so on and Dentistry specific subjects such as Prosthodontics, Periodontics, Orthodontics, and so on.

Postgraduate Section

The postgraduate library 3 sections- textbook section, journal section, and internet access section for elibrary. Recent editions of Journals are exhibited in the stacking cabinet together with at least three recent issues. Other journal issues and volumes are staked separately. Students can also refer the accessible back volume issues of the periodicals. The faculty urge students to use the library in order to install reading habits in them. Our library also has a new arrivals section that is updated monthly. A circular is also circulated to students and faculty to inform them of the recent additions.

There are established systems and procedures for maintaining and utilizing physical, academic and support facilities - laboratory, library, sports facilities, computers, classrooms etc.

Response:

The institute has evolved a structured mechanism for the maintenance of physical, academic and support facilities. The infrastructure of the college is efficiently maintained by the various maintenance sections. The budget allotment is made by the Dean and Management based on the requirements.

Classrooms

The institute provides well-equipped classrooms with high speed Wi-Fi enabled desktops. The students make use of the classrooms only during the lecture hours. To maintain cleanliness of the classrooms, students are asked to not to eat or litter the lecture halls. The electrical fittings and the furniture in the classrooms are always kept under working condition and repair works are attended to by the technical staff immediately.

Laboratory

The college has provided various costly equipments installed in the labs and they are maintained by the lab technicians and all major faults in the machines provided in the labs and operation theatres are taken care of by annual maintenance contracts. All minor problems in the equipments are attended by the technicians in the labs. In case the equipment becomes unserviceable within its service warranty period, it is returned to the suppliers for calibration service or replacement.

Buildings and Infrastructure

The maintenance of the buildings includes cleaning, painting, white-washing and replacement of fixtures & equipments in the building. There is adequate provision in the annual budget for these expenses. A maintenance team under a supervisor is functioning for undertaking the repair works of buildings and infrastructure. Similarly a fulltime plumber is available in the college for carrying out plumbing works. Daily cleaning of washrooms and the classrooms are done by house-keeping department.

Library & Computer Facilities

The computers used for various functions of the library and other related electronic gadgets are maintained by qualified IT experts who ensure trouble free performance of the computers. The maintenance of Wi-Fi facilities and updating of hardware and software are effectively carried out by the IT team.

Sports Facilities

Our college has both indoor and outdoor sports facilities. The stadium has facilities for various sports activities including badminton, volleyball etc. Students are allowed to utilize the sports facilities after college hours.

Other facilities

The college has a 24-hours electricity backup by Diesel Generators which ensures uninterrupted power supply in case of load shedding and power cut. For the supply of water also, the college has its own borewell and rain water harvesting installations. The college has appointed a team of fulltime technicians who visit all the electrical and water supply systems. Furniture includes the office, classroom, library and laboratory furniture which is maintained by Maintenance Committee.

The organizational structure of the institution comprises of governing body, governing council, IQAC, various committees and departments.

Decentralized and Participative Management

The college functions under the system of decentralized and participatory management. It is headed by a governing body which is constituted under the statue of the university.

Governing Body

It has 10 members with a Chairmen appointed by the parent body. It includes 2 members nominated by the university and a nominee from the government. It also includes inter-alia 2 members elected by the teachers of the college. The Director is the member secretary. The governing body takes major policy

decision.

The Dean being administrative head has decentralized the work into various committees consisting of senior faculty members. e.g.-The *Admission Committee* of college meets every student, verifies the documents, assesses his competence and prepares batches of advance learners and slow learners.

The *college academic calendar committee* prepares the academic calendar of the college giving details of various activities- Curricular, Co-curricular and Extracurricular.

There is a *Teaching Time Table committee* which prepare the time table giving details of the subject, name of the teachers and recess etc. The time table provides for Yoga/Meditation and provides for mentor- mentees classes.

Departments:

There is thorough distribution of work among the faculty and regular meetings at the departmental level are undertaken to discuss all academic and administrative matters. The Head of the Department represents the departmental concerns periodically to the Dean.

Every department has specific in-charge faculty to look after the academic activities of 3rd & 4th BDS students, Interns and Postgraduates. Administrative works like attendance, patient OP records, department library, indent records, maintenance, etc. are distributed to each faculty member in respective departments.

Office Administration:

There are Academic, Finance and General Administration sections with delineated staff supervised by the Registrar. The Dean coordinates with the Registrar in the smooth functioning of all administrative activities.

Participative management is reflective as under:-

The Director and the Dean of the college hold a meeting of all Heads of Departments whenever required but definetly on the first Tuesday of every month the Registrar and the Asst. Registrar also attend. All academic and administrative matters are discussed and dicisions are taken.

Earlier the Heads of every Departments hold meeting of the faculty in the department and the departmental issues are discussed and solved but if there are any problem needing interaction with Dean or Director. It is put up before the monthly meeting.

Outcome:

This mode of decentralized and participative management adapted in the institution facilitates better administration in all aspects. The faculty and students are also benefited through this modus operandi by indoctrination of leadership skills over the course of functioning in the institutional committees. This also leads to an harmonious atmosphere among all stakeholders.

Response:

The Institution has a clearly defined organizational structure with various committees constituted having specific objectives.

Organizational Structure:

Hitkarini Sabha, a registered society established in 1868is a non-profitable, Philanthropic organization extending literary & technical Knowledge in the Mahakoushal region of Madhya Pradesh and promoting moral, social & intellectual interest & wellbeing of the people. The Sabha is managing 8 colleges, 15 Schools and one Computer center enrolling more than 14000 students. As a registered society it is governed by the provisions of societies act. It is the apex body.

Council of Management:

The General body of the Sabha is a large body. Therefore there is a Council of Management which meets every month and takes managerial decision which can be solved at its level. Major decisions are referred to the General Body which meets quarterly.

Governing Body of the college:

The Governing body of the college is constituted under statute 28 Part 3 clause 6 (1) which provides the following.

- The Chairman of the Governing body of the college is appointed by the foundation society from amongst its members
- Two persons are appointed by the foundation society from amongst its members
- Two representatives of the University other than the members of the society of the college nominated by the executive council of the University.
- One representative of the donors of the college.
- One nominee of the government of the MadhyaPradesh
- Two representative elected by the teachers of the college who have completed other than the principal
- The Principal of the college shall be Ex-Officio member secretary.

The Governing Body takes decisions on all such matters as are provided in the Statutes of the University.

Director & Dean:

The Director is appointed by the parent body and takes day to day under Statute 28 of the University and performs all such academic & administrative duties

The Heads of department i.e. the Professor is supported by the Readers & the Lecturers as required under the rules of the Dental Council of India.

The Administrative wing is headedby Dean and the Registrar.

The institute has formulated the following strategic goals:

- Enhancing e-governance. Adapting emerging technologies in teaching learning process.
- To encourage the teaching faculty for active participation in research and publications Research grants by national and international funding agencies.
- Receiving insights from alumni and further implementation.
- To be recognized as an excellent centre for skill enhancement programs. To start fellowship programs in various fields of dentistry.
- To achieve good ranking from various agencies like NAAC, NIRF, NABH, etc., National and international recognition through academic excellence.
- Attracting students from diverse backgrounds.

6.3 Faculty Empowerment Strategies

6.3.1

The institution has effective welfare measures for teaching and non-teaching staff

Response:

The college has several welfare measures for its teaching and non-teaching staff. The employees get all such leave as is declared by the State Government. They get casual leave, academic leave, medical emergency and vacations. The employees get 15 days special leave on full pay at the time of demise of his mother or father. The employees get the benefit of provident fund and the contribution is deposited in the employees account in the employees Provident Fund office. The employees can also be sanctioned advance from the fund on request of employee for the marriage of the daughter and on other occasions. The Account slip is issued to every employee at the end of the year.

The employees are also covered under the benefits from Employees Health insurance Corporation and get free treatment for themselves and their family at notified hospital. The employees get medical treatment at the attested hospitals at concessional rate. The Students get free treatment and other benefit as required. The Hitkarini Sabha grants concession in fees to deserving poor students.

6.3.5

Institution has Performance Appraisal System for teaching and non-teaching staff

Response:

The college has a regular Performance Appraisal System for the faculty and sub-ordinate/non-teaching staff. It helps to boost employee engagement and productivity.

The appraisal system for the teaching staff

There is an appraisal proforma prescribed by the parent body. It consists of a structured questionnaire which includes (eg: Number of Theory & Practical classes taken; Methods applied for such teaching; Contribution to improve the teaching-learning process; Uploading e-content to facilitate for future learning of students, participation in teacher training / faculty development programs / national and international conferences; research guidance to undergraduate students, scientific publications; research grants received; timely response to the circulars and notifications sent from the Dean and punctuality.

The proforma is submitted to the dean who puts his remarks. The proforma is further reviewed by the director and forwarded to the parent body. Such recommendations will form the basis for faculty increments, promotions and any other incentives.

The appraisal system for the non-teaching staff comprises of

- The parameters taken into consideration for appraisal of non-teaching staff are Punctuality, Discipline, Neatness, Leave record, Behavior and relationship maintenance with superiors, colleagues and patients; Level of understanding of the allocated work; and Efficacy in executing the allotted work.
- Based on these parameters, monthly performance feedback forms will be obtained from the head of the department for the non-teaching staff working in their department.
- Monthly feedback forms will also be obtained from the supervisors, regarding the performance of the non-teaching staff.
- Both these forms for each non-teaching staff are assessed by the Director and Dean for releasing of incentives.

• The governing council's recommendations form the basis for annual increments.

Since the Dean is the appointing authority for the sub-ordinate staff, the final decision in respect of the subordinate staff is taken by the dean. The Dean, if need be, communicates adverse remarks made by the HOD to the employee in order to give a chance to defend himself. He can give his explanation in writing or may solicit personal hearing. The Director takes the final decision.

The advantages of such appraisal system are:

- 1.**Performance linked initiatives**: A good performing teaching / non-teaching staff, will receive incentives / encouragements.
- 2.Incentives for Research activities / Publications: Financial assistance is provided to the teaching faculty who regularly attends conferences and present scientific papers / posters; Achieve research grants; gain publications in reputed peer reviewed indexed journals as first author.
- 3.**Involvement in decision making**: Based on the proven competencies, the teaching faculty will gain importance to involve and contribute at the institute and university levels in the various committees.

6.4 Financial Management and Resource Mobilization

6.4.1

Institutional strategies for mobilisation of funds and the optimal utilisation of resources

Response:

All activities undertaken by an organization to secure new and additional finances, human and material resources is covered under the resource mobilization policy.

Inherent efforts to mobilize resources is the drive for organizational sustainability. It also involves making better use of and maximizing existing resources.

Income categories

- The institution is self-financed, and income is generated mainly from tuition fees collected from the students.
- Income generated from dental clinics and laboratories also contribute to the income.

Plan for Additional Resources:

- Introduction of fellowship courses and increasing the number of skill enhancement programmes.
- Enhance the revenue generated in the dental clinics by mobilization of more number of patients through awareness programmes and better patient care

Budget Plan

A budget estimate is drawn and estimated at the beginning of every financial year.

For budgetary consideration the cost incurred in the previous year is considered and any new developments planned for the year is included. This is submitted to the governing body for approval.

Income and budget - Expenditure is tracked every month by head of the institution and if there is any cost escalation, the same is put up before the concerned departments.

The expenditure is broadly divided into:

- Establishment charges such as salaries, operating expenses such as material cost, electricity, repairs and maintenance etc.
- Capital expenditure such as expenses towards dental equipment and building infrastructure.
- Academic and research expenditure such as expenses towards library, seminar and conferences sponsorships, community dental programmes.

Any new budgetary heads are created on need basis.

The resource mobilisation policy of the college is that it has to meet all its current expenditure from its own resources. However, if there is any deficit for some reason it is met by the parent body.

The college collects tuition fee and other fees as are approved by the State Government/Fee Fixation Committee. Normally the college does not collect any donation from anybody. The capital expenditure is met by the parent body i.e. all type of infrastructure: building, equipment, furniture etc.

Procedure for optimal resource utilization

The Accounts Department prepares the budget by collecting information from various departments. The college department submit their requirement for recurring expenditure on the basis of past expenditure and projected increase in quantity and prices on the basis of their past experience.

The budget of all departments are discussed by the committee of senior faculty members including HOD. The registrar of the college prepares the budget for faculty and contingency. The contingent expenditure includes various items electricity, water, taxes etc.

The purchase committee calls quotations, and the purchase is made at the lowest price. If need be it may have technical negotiation and commercial negotiation also. The recommendations of the purchase committee are approved by the dean/director and the order is placed.

The material is received by the central store dept. and after ensuring that the correct quality of stipulated

6.4.2

Institution conducts internal and external financial audits regularly

Response:

Internal Audit:

Internal Audit is an independent management function which involves a continuous and critical appraisal of the functioning of an entity with a view to suggest improvements to strengthen the governing mechanism of the institute. It helps the management to take right decisions about mobilization and utilization of funds, sources of income, utilization of the resource, compliance with laws etc. Internal audit is done periodically by the internal audit team so that the deficiency is immediately noted. Books of Account are maintained digitally by TallyERP9 integrated accounting software, besides the maintenance of bills and vouchers, documents etc., in physical mode. The Salaries of the staff will be paid in accordance with their appointment, after deducting for the statutory compliances such as Tax Deducted at Source, Professional Tax, EPF, ESI etc. Budgetary arrangements will be made to procure the relative equipment, materials, consumables etc. after obtaining the approval from the management. Further, other administrative expenditure such as Electricity Bills, Office Maintenance, Vehicles Maintenance etc will be paid on actual basis as per the approval received from the controlling authorities in the institute.

The Sources of Income of the institute is mainly from the Fee Collections from the students, Hostel Fee, Consultation, and treatment charges collected from the patients in the dental clinic. In this aspect the Fee Collections from the students are made as per the norms fixed by the Government and the management has no scope for intervention. The other items such as hostel fee from the students, treatment charges from the patients are incidental amounts collected at concessional rates just to support the actual expenditure incurred. The Management in compliance of the provisions keeps the funds with the Banks and other approved investments. The income accrued or earned thereon is shown as other income in the financial statements.

External/Statutory Audit:

The external audit is done by a qualified chartered accountant. He examine the Management Functions of design, implementation and maintenance of adequate internal financial controls that were operating

effectively for ensuring the orderly and efficient conduct of its business, including adherence to society's policies, the safeguarding of its assets, the prevention and detection of frauds and errors, the accuracy and completeness of the accounting records, and the timely preparation of reliable financial information. Auditors further verify the audit evidence, arithmetical accuracy and compliance of the statutory requirements and issue the audit report. Chartered Accountant audits the accounts quarterly and submit to the college. It is discussed in the Governing Body. Action, if any required is taken immediately and audit objections, if any, are answered and removed in time. The audit reports are also submitted to the parent body which examine and put their suggestions if any required. It may be stated that no major financial irregularity has ever been noted in the college accounts since its establishment. Statutory audits have been completed up to the latest financial year.

- To organize workshop / seminars on quality related themes.
- To document various activities leading to quality improvement.
- To develop quality culture in the institution.
- To prepare Annual Quality Assurance Report (AQAR) as per guidelines and parameters of NAAC.

The Dean of the college along with the Academic Audit Committee reviews the students attendance, Conduct of practical and seminars and the annual examination results. He meets the students, take their feedback make suggestions for improving the academic progress. In connection with the administrative audit he reviews the Registrar office, attendance of the faculty and staff, there is a competent committee for purchases and stores. Their work is also examined. Regular meetings are conducted by the Director of the college and the first Tuesday every month but if need be meeting are held in between. He also takes the feedback from all Heads of the Department and the Dean. Problems, if any, are carried to the Governing Body and Parent Body for a solution. Additional money for purchase of new/modern equipment for lab and improvement/additions to the infrastructure are also discussed so that additional fund may be made available by the Parent Body.

The functions of IQAC are

- 1. Review all academic related activities like teaching-learning, clinical skills, evaluation processes and result analysis.
- 2. Assess the feedback reports on various activities in the institution.
- 3. Assess screening and treatment quality in Community outreach settings
- 4. To improvise the quality of library facilities and better utilization of the same by students and faculty.
- 5. Review the reports given by the committees and gives its suggestions for excelling in sports and cultural activities.
- 6. To emphasize the inculcation of research culture among the students. The cell also monitors grants from various funding agencies and scientific publications.
- 7. To organize workshop / seminars on quality related themes.
- 8. Preparedness for Accreditations by various agencies is reviewed by IQAC.
- 9. The IQAC reviews the existing MOUs and gives suggestion for new collaborations.
- 10. The IQAC monitors the maintenance and recommends upgradation of Infrastructure facilities.

The Internal Quality Assurance Cell conducts regular periodic meetings. This cell is not another hierarchical structure or record-keeping exercise in the institution; it is a facilitative and participative voluntary system/unit/organ of the institution.

Response:

Hitkarini Dental College and Hospital follows standard guidelines for waste management and has facilities for efficient management of different types of wastes generated.

SOLID WASTE MANAGEMENT:

Solid waste is disposed as per Solid Waste Management protocols. The institute does not generate any hazardous solid waste. Non- hazardous solid waste is collected as per standard protocol and segregated into biodegradable and non-biodegradable waste. Biodegradable waste generated in the form of garbage

through regular maintenance. The non-biodegradable waste is collected by the local Municipal Corporation for safe disposal.

LIQUID WASTE MANAGEMENT:

The Institution has Sewage Treatment Plant (STP) facility is available in the campus with capacity of filter 80 liters water per hour (80 l/hrs). It reduces the release of disease causing organisms into the environment. The hazardous liquid waste generated from the college labs is put in a separate tightly capped labeled container and disposed off-site by the concerned service company with which the institution is tied up with.

BIO-MEDICAL WASTE MANAGEMENT:

Bio-medical waste is managed as per Bio-medical waste management rules, 2016. Hitkarini Dental College and Hospital is registered with MP State Pollution Control Board for disposal of biomedical waste as per the standard protocols of the Board. All generated biomedical wastes are segregated in colour coded dustbins with standard polythenes placed over them in all departments. Waste is cumulated/collected at a designated area and disposed as per standard protocols. The institution has a memorandum of understanding (MOU) with for disposal of bio-medical waste generated in the institute. Training and awareness programs on Biomedical waste management are also regularly conducted for all students, teaching and non-teaching faculty.

E - WASTE MANAGEMENT:

E waste is managed as per the E-Waste Management Rules, 2016.

E-Waste generated (computer accessories, servers, printers, batteries, ACs, refrigerators, telephones, Xerox machines, etc.) from all the departments is collected at consigned location and handled in an eco-friendly way.

E-waste is disposed as per SOP for condemnation and disposal of items to registered E-waste recycling companies.

Rapid development is being witnessed currently in the field of dentistry. The students need to be trained with the concepts of basic principles, diagnostic procedures with latest gadgets, treatment planning and execution. All sub-specialties work hand in hand to develop perfection in the specialty to match with upgradation of knowledge and skill, calling for extensive interdisciplinary approach. The need was felt to have properly established mechanism, i.e., CPC cell which will function to train students to showcase the cases of interest treated with multidisciplinary approach. CPC proved to be extension module for existing training program in developing the postgraduate students with comprehensive treatment approach.

Objectives

- A common platform for postgraduate students to showcase cases treated by interdisciplinary approach
- Utilization of latest diagnostic tools, procedures, planning the treatment with possible outcome Competency based approach and evaluation
- To develop a quality of orator with confidence and ability to interact with faculty and answering the queries

Guidelines

- Annual timetable to be prepared and circulated in advance to all departments.
- Notification for each activity at least a week before.
- Compulsory for all PG students and Interns to attend.
- Only completed cases treated by multidisciplinary approach are permitted,
- Moderation by senior faculty from concerned department
- The PowerPoint presentation has to be approved by post graduate faculty and HOD and to be submitted 3 days prior to event.
- Queries solving session before awarding certificate of presentation. Entry to be made in log book. The presentation should be converted into publication.
- The activity will be suspended during examination and vacation period.

This activity was started in the year 2020 and is conducted once per month. The timings are 9.30 am to 10.30a m at the ICT enabled Auditorium with audio – visual aids. During pandemic period (COVID-19), the activity was suspended.

Conclusion

Being interdisciplinary activity with involvement of more than two departments for showcasing completed cases by multidisciplinary approach is presented. The latest diagnostic procedures with radiological interpretation and histopathological evaluation, planning of treatment is done with execution of treatment. The final outcome is witnessed by the audience and criticism/appreciation with openness is done by question answer session. The presenter and audience will understand the comprehensive approach adopted for treatment.

It proved to be excellent module of extended teaching learning of high magnitude. A platform with experts is available to all PG students and interns to learn and solving their queries. The summation of the presentation with expert comment is done by moderator as a take home message.

The management extend required support in making this activity successful. It is noteworthy to state that this activity has arose interest amongst the PG students with healthy competition to showcase their cases with latest and complete information, well supported with photographs, tables and cross references available in literature.

8.1.2

The Institution ensures adequate training for students in pre-clinical skills

Response:

The heart and soul of innovation in education ecosystem is our ability to improve human knowledge base in a structured manner that can benefit students, the discipline, and the society. Effective preclinical training is ethical and extremely important for patient safety. Preclinical training helps the students for a smooth transition from preclinical to a clinical situation which could be highly stressful.

Adequately preparing the students for smooth clinical transition poses a great challenge for educators. The preclinical training provides a learner centered education without clinical responsibilities, sometimes far away from the situation it wants to imitate. We believe that task based preclinical training more similar to clinical practice will help the students to overcome the stress during initial clinical practice. Psychomotor skill development is usually achieved by incremental training in preclinical courses before declaring the student competent for clinical training.

The carving exercises in dental anatomy develop the art and skill of individual to mimic human tooth anatomy that would be extremely helpful in clinical fabrication of restorations and prosthesis. The carved models, casts, microscopic slides and museum specimens in Dental anatomy help lay the required foundation for future clinical activities. There are phantom heads installed in the Department of Preclinical Prosthodontics where the students observe, learn and do the practical exercises on mounted models which simulate the patient. Innovative ideas are always encouraged by including Focus group discussions (FGD's), early clinical exposure and audiovisual aids (videos, demo clips).

In Pre-clinical Conservative Dentistry, working on phantom head with jaw sets simulating the human dentition help the students develop skill and confidence required to perform the same in patients as it simulates the oral cavity. In addition they practice on plaster models, which replicate the anatomy of human teeth and are larger in size helping student learning easy.

The science of dental material is arguably the most important subject a dental surgeon should learn. Dental material exercises in Prosthodontics and Conservative Dentistry help students develop critical understanding of factors that that determine their clinical application. Pre- clinical Orthodontics are aimed to develop manual dexterity among students via wire bending exercises. Cephalometry and photography skills are emphasized.

Training in Anatomy involves the study of dry bone of the head and neck and the Study of the internal structure of the body by dissection method. Study of the histological slide through compound microscopes and the embryonic development by models is practiced. The Physiology department has laboratory for the training and develop the skills of the students in different hematological and physiological experiments. Pharmacology forms a bridge between the theory and practice of medicine. Pharmacological practical exercises make understand different action of drugs. Prescription writing is developed and management of emergencies as well as drug interactions is emphasized.

Understanding of the subjects of Pathology and microbiology is of utmost importance to dentists as it gives an insight about various inside about various pathologies and microorganisms involved in the causation of the oral diseases and help in confirming the diagnosis and treatment planning more efficiently.

Orientation of fresh students for the new entrant:

It is essential to make them aware with details about dentistry by providing information about institution and various departments including library and hospital. The apprehensions in their minds have to be carefully eliminated by way of organizing Orientation Programs for dentistry. Various curricular and extra-curricular activities including functioning of Examination Cell, Attendance Cell and discipline related issues including anti-ragging measures taken by institution to curb the menace of ragging are informed. This programme in planned by college to welcome the freshers to eliminate the fear complex. This program results in strengthening the 'Bond of Friendship' between freshers and seniors and also to develop close association with the faculties. A tour is conducted to introduce various departments/cells to know the location and functioning. The code of conduct is explained to students which will help in achieving desired behaviour in campus. The convenor of exam cell explains the importance of internal assessment examinations and the schedule of conduction of examination. The Academic-in-Charge briefs about the Academic Calendar and academic activities. The in-charges of various cells inform about functioning of their cell. White coat ceremony This programme is organized to sensitize freshers about dress code and importance of apron. Aprons are distributed ceremonially to the students in presence of management and faculty. The importance of wearing white coat and respecting the symbol of the profession is narrated by Dean. Chairman and Director including all HODs grace the occasion.

Workshop on Patient care:

The students are sensitized through workshops regarding patient care. Receiving patients with respect, developing better rapport with interaction, thorough examination, proper diagnosis using X-ray/ lab test for proper diagnosis and treatment planning etc. is narrated by faculty. Sterilization protocol, safety measures for patient and self is also explained. The Ethical Issues, Value Education and Communication Skill, Ergonomics in Dental Practice etc are also informed. Briefing on Infection Control, Biomedical Waste Management, Green Campus and Environmental related issues etc are explained by presentations. Internship Orientation After successfully completing the course, students are exposed to well-planned Internship Program designed by DCI.

One-year Compulsory Rotatory Internship' by stipulated posting in all departments carried out as per time frame and number of patients/exercises has to be completed by interns with credit recorded in logbook. Internship is considered as 'an opportunity to revise the knowledge without fear of examination' to acquire desired level of competencies to practice dentistry successfully. Orientation Program is organized for fresh interns where the importance of internship related with duties and responsibilities including behaviour are explained by Dean, Director and senior faculties. Interns are posted for Dental camps in rural areas/schools, jail, primary health centres, satellite centres to develop skill to handle community related issues. The Institution has introduced objective methods to measure and certify attainment of specific clinical competencies by BDS students/interns as stated in the undergraduate curriculum by the Dental Council of India

Response:

Exam Cell and Its Reforms

The 'Exam Cell' is functioning since its inception. The evaluation of the proficiency of students is carried out by:

- Periodical test during clinical posting
- Three Internal assessment examinations as per the schedule per the guidelines of DCI/University.

The reforms carried out in the Exam Cell:

- 1. Validated LRM prepared by departments is stored
- 2.The Question Bank is available subject wise, stored in system of exam cell as LAQs, SAQs and MCQs well supported with the Model Answers.
- 3. Answer books are evaluated using model answers and moderation is done by senior faculty for awarding proper marks
- 4. These valued answer books are then shown to students for tally of marks awarded. Corrections, if any, are done before declaration of result, in a transparent manner.

Clinical Competency

The clinical competencies of student are evaluated by the department during practical/clinical examination held during internal assessments. The structured program for conduction of examination as approved by department exam cell is implemented under the supervision of Exam cell.

The clinical examination comprises of:

1. History and examination of patient

- 2. Observation of each clinical step performed by the students
 - 1. Chairside viva to assess the depth of knowledge
 - 2. Evaluation of completed clinical exercise for outcome
 - 3.In clinical subjects where patient is not required, suitable exercises are allotted in addition to above, Continuous assessment system is in place. Departments are instructed to conduct class tests and evaluation of skills in practical/clinical hours, after completion of clinical step/practical exercise and records are maintained. Students are then guided to overcome the shortfalls. Corrective measures are taken in consultation with Exam Cell.
 - 4. Self-assessment: The listed clinical/practical exercises are given to the student to complete in a time-bound manner and they are trained to evaluate their own performance. Shortfalls noticed are discussed with students by the faculty for improvement.

Internship

After passing the Fourth BDS examination, every student has to undergo 'One-year Compulsory Rotatory Internship' as per DCI regulations. The interns are posted department wise and allowed to treat the patient under the supervision of faculty and the clinical competency is assessed by the faculty for the attainment of their clinical skill and necessary entries are made in the log-book with gradation.

The College has adopted methods to define and implement Dental graduate attributes with a system of evaluation of attainment of such attributes.

Response:

The student should respect patient and the community while treating them. The students should learn in maintaining documents and records for future references, including medico-legal complications. The institution has developed a system to inculcate attributes in dental graduates: Orientation programme for freshers: They are introduced to various departments of Dental / Medical subjects. 'Code of Conduct' and discipline related matter is explained during this program. The curriculum, system of evaluation, importance of attendance and healthy practices i.e. Mentorship Programme, Students support programme, Hostel and Mess, Anti-ragging Measures, Grievance Redressal Cell, Women Cells and various cells information is given to the students.

Implementation

Students are informed about syllabus. The time table is meticulously framed in accordance with DCI regulation. Departmental Curriculum Committee suggest changes to University, if any, in syllabus to include the recent advances suggested by Departmental Curriculum Committee and Academic Review Board. The syllabus is categorized as Must know, Desired to know and Nice to know. The question bank with model answers is available for setting the question paper under Must Know, Desired to know and Nice to know. A clinical training is imparted by faculty to make student able to diagnose and treat various dental patients independently under supervision of staff. To handle emergency in dental practice, students are properly trained along with Basic Life Support measures. The library is having sufficient text and reference books including national and international journals to cater the need of UG and PG students. Ample space with furniture and fixtures is available for the comfort of students and staffs. Facility of Book Bank is available to the students. The library is augmented with E-learning resources including Wi-Fi and LAN. .

Evaluation

The Exam cell conducts Internal Assessment Examination. Setting of question paper, valuation and moderation of answer book is carried out and students are shown answer books for any queries before declaration of result. Slow and Advanced learners are identified for undertaking corrective measures. The Student Counselling Unit is functioning along with Mentorship Programme for improvement. The Gymnasium and yoga Ha ATM, Hostels and Canteen/ Mess/ Restaurant and Laundry facilities are available in campus. 24x7 Security services including CCTV surveillance is in place. The Feedback Mechanism to evaluate the perceptions of the stakeholder is in place and analysis of feedback is done for corrective measures as per need.
